Your BMABA instructor insurance, which is served in conjunction with membership, is now active and live as of 28/10/2023. Insurance is not something that should be 'shut in the top draw' and forgotten about until renewal. It's really important our members know that insurance is not an unconditional layer of protection. As always, there are important conditions and exclusions. Martial Arts has a habit of not really understanding what insurance is for and quite how it works and we're working to change this. **We need your help.**

Now that you have your instructor insurance live with us under the representative policy number INS/16004/AQE there are a few important things you must do;

- ◆ **Check your instructor insurance documentation** straight away to ensure it is fitting and accurate to your current circumstances. Check the weapons, styles, liability amounts and dates are per your requirements.
- ◆ **Make sure you remain compliant with the policy requirements** throughout the year. This includes every instructor holding a First Aid Qualification. If you work with children or adults at risk, you will also need an enhanced DBS check (or PVG scheme if in Scotland) and safeguarding qualification. This is really important; cover is not live without this. Fully details on the essentials needed to remain on-side with the policy, including supporting checks (such as risk assessments etc) can be found in our Knowledge Base, in MyBMABA or the MyBMABA App. Please do double check this.
- ◆ **Read the policy wording and example claims form** to make sure you understand what cover exists and what conditions apply. This isn't a thrilling read, we know, but it is important. No insurance policy will automatically pay out in the event of a claim. There are always conditions and exclusions.
- ◆ **Ask questions if you're not sure.** There's never any such thing as a silly question when it comes to insurance, just as there is never such a thing as a guaranteed claim so please do everything you can now - before you depend on the insurance - to prepare the ground in your favour. Much in the same way you wouldn't teach your students to use a block for the first time in a real fight, you shouldn't wait until you have a claim to understand the mechanics of cover. 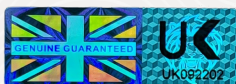
